INFORMATION PURSUANT TO ARTICLE 13 OF LEGISLATIVE DECREE No. 196/2003

Dear Guest,

We would like to take this opportunity to inform you about how we use your personal data. This data refers to the information you are about to provide us by completing this registration card. The data will be processed by Pirovano Stelvio S.p.A., the data processing controller, in order to manage your reservation application. The data processing activity includes its registration and transfer to the Hotel. Pirovano carries out all activities using manual or IT means: directly, using its own employees or through responsible outside parties. The data will not be communicated or transferred to third parties, and not even rendered public, outside the previously described contexts.

Authorisation when booking

Certain information must be provided when making a reservation. Otherwise, the request cannot be processed. Mandatory data is clearly highlighted.
